- Long pants and boots required; gloves recommended.
- Numbers will be supplied.
- ZERO TOLERANCE FOR DRUNKENESS OR ALCOHOL ON SITE
- Must have lawnmower style hood/fenders/frame (no suspension)
- Lawnmower turf or stud tires allowed – no ATV or lug tires.
- Minimum 5 inches or 12.7 cms ground clearance to lowest part of frame or axle
- Must have breakaway type kill switch.
- Exposed belts and chains must be guarded.
- Throttle may be twisting grip, thumb throttle, squeeze grip or foot pedal (must have positive return spring)
- Must have working brakes of any type.
- Mower decks optional – blades must be removed.
- No glass (headlights to be taped or removed)
- DOT approved helmet with goggles or face shield
- Neck braces recommended.
- Number to be displayed brightly on both sides and back (8 inch or 20.32 cm high minimum)
- “Out of Box Stock” - No internal modifications. External modifications allowed.
- Open headers, disconnected governor, modified air cleaner and gearing (pulley) change.
