* NEW! Horse Council BC Insurance: All riders must provide proof of current HCBC membership.

Stabling: in barn (pre-booked) \$12/night; **OR** livestock camping (BYO panels etc. – no early booking) \$30/night you and your horse in Wilderness Campground – pay campground attendant when you arrive (cash).

*All gate and/or camping fees to Fair are separate from Obstacle Challenge entries and must be paid at gate and/or campground, cash only. There is no camping available at the trailer parking on the Fair neighbour's property.

All riders under 18 must wear ASTM/SEI approved helmets with chin strap attached ANYTIME while mounted at the fairgrounds.

Please pay attention to signage on the grounds, we want to keep everyone safe so please WALK your horse in the barnyards and alley to arena. Also, as there are many vehicles, visitors, and other users of the arena through the livestock gate and parking lot during the weekend, walking/riding your horse beyond the warm-up arena is not permitted.

Obstacle Challenge – GAMBLER'S CHOICE:

Entry Fee: \$15.00 (will be added to prize payouts)

Prize money split: 1st – 45%, 2nd – 35%, 3rd – 20% **Over \$450.00 prize money before entry fees added!!!!!!**

OPEN – no age/division categories

Description:

We will have 20 – 30 participants. This is a timed event, and each participant has 2 minutes to successfully complete as many obstacles on the obstacle course as he or she can. The course is specifically designed to challenge the participants and horses. The course will consist of about 10 obstacles, each one is worth a specific point value based on degree of difficulty. Participants are allowed to do an obstacle twice, but they cannot do the same obstacle back to back. The participant who earns the highest point total is the winner. Western or English tack allowed. Ride or In-Hand allowed.

Additional Rules:

*Any step off is a no score on that obstacle. Incomplete obstacles are no score. Obstacles must be 4 feet in/4 feet out. Walk only across any wood obstacles, otherwise there is no pace limit. A map with obstacles and points will be provided beforehand. There will be 2 judges for the course.

* If you do not cross the finish line before the 2 minutes is up, the last obstacle scored will not count. A 15 second warning will be given.

*Ride and In-Hand will compete together. Obstacles will be intermediate to advanced levels. Previous experience recommended.

*Last to register will be first to race, so get your entry in early – limited space!
