- **Waivers: ALL RIDERS MUST SIGN WAIVERS.** Waivers are attached OR can be downloaded from the Fair website at <https://www.rockcreekfallfair.ca/entry-forms> (please ensure you use the correct form – either *Over the Age or Majority or Under the Age of Majority*)
- **NEW!! Horse Council BC Insurance:** All riders must have, and provide evidence of, valid Horse Council BC Insurance.

There are 4 age groups: Pee Wee (9 & under), Junior (10-13), Intermediate (14-17), Senior (18 and up). If you are 9 or 13 and have been competing in higher division this season you may enter that division.

**Stabling** – in barn (pre-booked) \$12/night; or livestock camping (BYO panels etc. - no early booking) \$30/night you and your horse in Wilderness Campground, pay campground attendant when you arrive.

All gate and/or camping fees to Fair are separate from gymkhana entries and must be paid at gate and/or campground, cash only. There is no camping available with trailers at trailer parking area on Fair neighbour's property. Fair Admission Tickets can also be purchased online starting August 1, 2023, at [www.rockcreekfallfair.ca/tickets](http://www.rockcreekfallfair.ca/tickets)

Ribbons to 5<sup>th</sup> place. Prize money to 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>.

There will be High Point and Reserve High Point prizes awarded to each age category. If points tie, High Point will be awarded to rider with fastest barrel time. Costume Class not included in High Point. Patterns will be posted at arena. Please know your pattern before entering the arena.

**All riders under 18 must wear ASTM/SEI approved helmets with chin strap attached anytime while mounted at the fairgrounds.**

### Gymkhana rules:

5 second penalty for knocking over a pole or barrel.

Disqualification for going off course.

Rider must be in control of horse at all times.

Organizers have final discretion on penalties, disqualification, or elimination.

Pee Wee riders cannot be led; however, parents may stand inside arena. \*If PeeWee rider needs to be led it is up to Organizer if there is time allowed and how placement will be given.

**PRIZE MONEY CHEQUES WILL BE MAILED OUT AFTER SEPTEMBER 24, 2023, SO PLEASE MAKE SURE YOUR MAILING ADDRESS IS COMPLETE ON YOUR ENTRY FORM!!**

Please pay attention to signage on grounds. We want to keep everyone safe so please **WALK** your horse in the barnyards and alley to arena. Also, as there are many vehicles, visitors, and other users of the arena through the livestock gate and parking lot during the weekend, walking/riding your horse beyond the warmup arena is not permitted.
